Hi Scott,

As we discussed, the idea is to create a new venture competition here in Eastern Oregon. We will recruit new venture teams, coach them up, and then host a competition. The most promising teams will receive a venture package with cash, coaching, and business services (legal, accounting, payroll...) – the amount of these awards (one/many) is still TBD. This type of program has worked very well in Beaverton, Portland, and a number of other communities.

We would like to start by raising \$25,000 in seed funding from local/state government. This money will be contingent on raising matching funds from independent (angel) investors here in Eastern Oregon. The angel investment will serve to match the seed investment in the winning ventures. Angels investors, will not only be investors, but they will also serve as mentors for the ventures/entrepreneurs. This particular element is key to the success of the ventures and will also get some more influential business owners involved in economic development here in this part of the state.

Steve Morris, who runs OTBC (Beaverton, OR), has had a program similar to this for many years, and he is willing to work with us to help set it up. Once we have it up and running it will be our job to expand and sustain the effort.

We are happy to put all the pieces together here at EOU with the help of other community partners involved in entrepreneurship and economic development. We would be happy to host the competition and get our students involved through our entrepreneurship program (though this competition is NOT limited to EOU students).

Think we could do a lot of good here starting with very little. Plus, we will two for one style economic development leverage.

Can we pull together a team and see what is possible?	Would love to see what we can put together.
